

LISVANE COMMUNITY COUNCIL 2025-26 ANNUAL REPORT

I am pleased to present the Annual Report of Lisvane Community Council (LCC) for the year ending 31 March 2026.

BUDGET

The Council's only significant source of **income** is its Precept. This is the amount that Cardiff Council collects from Lisvane residents for LCC as part of its Council Tax

arrangements. The Precept in 2025-26 was £84,500. For the typical household in Lisvane this amounts to around £3 per month.

The Council's **expenditure** largely related to:

- Finance Costs (for redevelopment funding of Lisvane Old School Community Centre)
- Staff Salaries and Pensions
- Grants to community groups including Lisvane Community Library Assoc (to cover their rent), Lisvane Book Festival, Friends of Coed Y Felin, Friends of Parc Cefn Onn, Lisvane Walking Football and Lisvane 50+ Club
- Funding to maintain the Community website
- Maintenance of Lisvane War Memorial

A full breakdown of expenditure is available in the Annual Accounts. All Councillors waived an annual allowance payment to each of them of £156 and none claim the attendance allowance of £30 per meeting.

RELATIONSHIP WITH CARDIFF COUNCIL

The Council works closely with local Cardiff County Councillors Emma Reid-Jones, Sian-Elin Melbourne and John Lancaster and has a very good working relationship with Cardiff Council Senior Officials and Staff.

In January 2019, along with the other Community Councils in Cardiff, LCC signed a Charter with Cardiff Council which sets out a framework of how Community Councils and Cardiff Council can work together. Regular meetings are held with the Director of Legal and Governance at Cardiff Council along with meetings with the Head of Planning and Electoral Services Manager

TRAINING PLAN

All Community Councillors attend training courses as appropriate and LCC is a Member of One Voice Wales which undertakes most of the training needs of local Councils. A Training Plan for Members and staff has been published on the website.

AUDIT

Accounts ending 31 March 2026 will be subject to an Internal Audit by a qualified Accountant and also an External Audit by the Auditor General for Wales. The outcome of all Audits are published on the Council's Website.

STANDARDS COMMITTEE

Representatives of the Cardiff Council Standards Committee periodically attend and observe meetings of the Council and then provide feedback. The last visit was 10 November 2025 where the Observer commented that management of the meeting was "very good"

KEY OBJECTIVES FOR 2025-26

The Council's main objective was to make a success of the Lisvane Old School Community Centre following its recent redevelopment by working closely with its Trustees. An additional part time member of staff was appointed wef 1 April 2022 in order to ensure that the community centre is properly resourced and supported.

The Council will continue to scrutinise every planning application and to make comments to the Head of Planning where appropriate. Members are pleased that a number of its Objections and Comments made in 2025-26 were upheld by the Planning Authority.

The LCC is actively consulting on the Replacement Local Development Plan.

ASSETS

The Council owns the freehold land of the Lisvane Old School Community Centre which is leased to Trustees who run it.

The Council also owns the Lisvane War Memorial

ACTIVITIES

The Village Plan team is a group comprising of representatives from various community groups and during 2025-26 was actively addressing wellbeing issues within the community. The group has supported a number of events aimed at tackling loneliness and exercise for older people. During the year the team set up an informal weekly Welsh language group to encourage and support Welsh learners of all levels. Similarly the team has made good progress in setting up a walking football activity and has also consulted with the community on how S106 Open Space Contributions can be used to improve the Heol Y Delyn playing field

The Council provides funding for the community Library's annual rent which enables it to operate from the Lisvane Old School Community Centre

In conjunction with the local Churches and SW Police the Council is pleased to facilitate the annual Remembrance Sunday event at the War Memorial.

RELATIONSHIP WITH COMMUNITY GROUPS

LCC is represented by three Members who have been appointed by LCC as Trustees of Lisvane Old School Community Centre as well as being represented on the governing body of Llysfaen Primary School by Cllr Williams. Three Members are part of the Lisvane Environmental Group and several Members are actively involved with the Friends of Cefn Onn Parc and the Friends of Coed Y Felin Woods.

LCC is pleased that Tomorrow's Generation (TG) occupies the annexe at Lisvane Old School Community Centre. TG is a dyslexia school for young people (age 7-11).

LCC has a close working relationship with the local Police and in particular with the Police Constable Support Officer and is represented at PACT meetings by Cllr Hanson. PACT stands for Partnerships and Communities Together and is a forum where the Police and other community groups that Lisvane serve meet with residents.

The LCC is pleased to support the expanding services of the Community Library and provided grant funding for their 2023, 2024, 2025 and 2026 Literary Festivals.

ACHIEVEMENTS

The Council's main achievement in 2025-26 was to jointly manage with Trustees the successful running of Lisvane Old School Community Centre following a major redevelopment of it. Feedback from residents has been hugely positive and the centre has become a vibrant and key part of the community. Its popular café is used by visitors of all

age groups and a wide range of community activities take place at the centre 7 days a week. LCC was able to borrow sufficient funds from the UK Public Works Loan Board and Members are confident that the loan structuring and financial arrangements made will ensure that debt serviceability will continue to be affordable particularly as all existing borrowing is charged at a low fixed rate of interest.

The Council also manages a Lisvane community website. In addition to part of the website being used by LCC, much of it features details of most if not all of the community groups in Lisvane

PRIORITIES

To build on the success of Lisvane Community Centre to date and to take it forward to meet the needs of an expanding community

SUMMARY BY CHAIRMAN

As previously, the year has been busy for all Councillors and particularly the Clerk to the Council and the Admin Officer. Our thanks to both of them for their continued enthusiasm, support and hard work.

The LCC was sorry to accept the resignation of Councillor Ron Kelly, who has given many, many years of service to the LCC and the community. He will be sorely missed.

The Old School Community Centre has continued to grow as a successful facility providing a range of interesting activities for all ages, and as a social meeting place centred around the well used café. LCC has continued to support its operation, and maintain and upgrade the building and internal facilities as appropriate.

The LCC will be commenting on the upcoming implementation stages of large housing developments already approved in principle in the area, and the broader updated Cardiff Replacement Local Development Plan (2020-2035) which includes further potential developments. All efforts will be made to ensure that these developments will not destroy the village.
